CARGO HANDLED AT STATE MARITIME/ STATE DIRECTORATE (Non-Major Ports) DURING AND UP TO JANUARY, 2019

Total Cargo traffic at India's State Maritime/ State Directorate

Maritime transport activity is driven by developments in world economy, viz, growth in world output and trade. Thus, volume of seaborne cargo traffic handled by ports is mainly shaped by the levels and changes in both the global and domestic activity. Cargo traffic at Non-Major Ports during **April-January**, **2018-19**, **increased by 9.6% to 477.58 million tonnes** from 435.59 million tonnes handled during April-January, 2017-18.

The overseas cargo handled at Non-Major Ports during April-January, 2018-19 increased by 8.8% to 402.03 million tonnes from 369.58 million tonnes during April-January, 2017-18. However, the coastal cargo handled at Non-Major Ports during April-January, 2018-19 increased by 14.4% to 75.54 million tonnes from 66.01 million tonnes handled during April-January, 2017-18.


Port-wise Cargo traffic handled during January, 2019

- Cargo handled at Non-Major Ports during January 2019 is 50.17 million tonnes showing an increase of 5.2% in the corresponding period of the previous year. However, the coastal cargo handled at Non-Major Ports during January, 2019 increased by 2.5% to 8.0 million tonnes from 7.8 million tonnes during January, 2018. The overseas cargo handled at Non-Major Ports during January, 2019 increased by 5.7% to 42.17 million tonnes from 39.90 million tonnes during January, 2018.
- During January, 2018, the Non-Major Ports of Tamil Nadu Maritime Board posted highest growth in traffic of 41.8% followed by the Non-Major Ports of Directorate of Ports, Andhra Pradesh (22.4%), Directorate of Ports, Karnataka (6.2%), Gujarat Maritime Board (GMB) (3.7%) and A&N Islands (0.9%). The State Maritime/ State Directorate which recorded negative growth in January, 2019 are Captain of Ports, Goa (65.4%), Directorate of Ports, Odisha (14.6%), Directorate of Ports, Puducherry (3.4%), Non-Major Ports of Maharashtra Maritime Board (MMB) (3.1%) and Directorate of Ports, Kerala (2.8%).
- Amongst the State Maritime/ State Directorate, Gujarat Maritime Board handled the maximum cargo traffic at 34.76 million tonnes with a share of (69.3%) in the total cargo handled at State Maritime/State Directorate followed by Directorate of Ports Andhra Pradesh (17.5%), Maharashtra Maritime Board (8.0%), Odisha (3.2%), Puducherry (1.2%), A&N Islands (0.3%), TNMB (0.2%) and Karnataka (0.1%).

- At a broad commodity level, Fertilizer achieved highest growth of 25.0% in January 2019 followed by Coking Coal (22.9%), Thermal Coal (20.5%), Other Coal (14.5%), Others Commodities (9.8%) and Container (5.2%). Food grains excluding Pulses recorded highest negative growth of 27.0% in January, 2019 followed by Edible Oil (15.7%), Iron Ore Pellets/ Fine (12.7%), POL products (7.9%), Cement (6.9%), POL crude (6.3%) and LPG/LNG (0.7%).
- At a broad commodity level, POL crude handled the maximum cargo traffic of 9.18 Million tonnes with share of 18.3% in January 2019 followed by Container (14.5%), thermal coal (11.1%), other commodities (10.4%), POL Products (10.4%), Other Coal (9.2%), Iron ore Pellets/ Fine (7.5%), cocking coal (5.7%), LPG & LNG (3.6%), Fertilizer (2.4%), Cement (2.3%), Other Ores (2.1%), Iron & Steel (0.8%), Edible oil (0.5%) and FRM liquid (0.4%).

Cargo traffic handled during April-January, 2019

During the April-January, 2018-19, Maharashtra Maritime Board recorded highest growth in traffic at 26% followed by Directorate of Ports Andhra Pradesh (22.4%), Directorate of Ports Kerala (16.2%), Directorate of Ports, Puducherry (8.2%), GMB (6.8%), Directorate of Ports Karnataka (6.2%) and A&N Islands (0.9%). State Maritime/ State Directorate that recorded negative growth in traffic during April-January, 2018-19 were: Captain of Ports, Goa (77.8%) followed by Tamil Nadu Maritime Board (22.7%) and Directorate of Ports, Odisha (14.6%) over April-January, 2017-18 (Table1).



Amongst the State Maritime/ State Directorate, Gujarat Maritime Board handled the maximum Cargo of 327.87 million tonnes with a share of 68.7% followed by Directorate of Ports, Andhra Pradesh (18.4%), Maharashtra Maritime Board (7.5%), Directorate of Ports, Odisha (3.4%), Directorate of Ports, Pudducherry (1.4%) and A&N Islands (0.3%) during April-January, 2018-19 (Graph 1 above).

- During the April-January, 2018-19, Project Cargo recorded highest growth in traffic at 65.6% followed by Edible Oil (64.5%), Other Coal & Fertilizer (27.6%) each, Iron Ore Pellets/ Fine (14.6%), Container (12.8%), Coking coal (11.3%), Other Commodities (7.2%), thermal coal (6.7%), LPG & LNG (4.7%), POL Products (3.6%) and POL Crude (2.4%). Pulses recorded highest negative growth 90.5% in traffic during April-January, 2018-19 followed by FRM Dry (72.5%), Building Material (54.0%), Food grains excluding Pulses (27.0%) and Iron & Steel (12.7%) over April-January, 2017-18 (Table 2).
- Amongst the all commodities, POL crude is the highest commodity handled at ports of 81.36 million tonnes with a share of 17.0% followed by Container (14.7%), POL Products (11.3%), Thermal Coal (11.1%), Other Coal (10.7%), Other commodities (10.5%), Iron ore (8.1%), cocking coal (5.1%), LPG & LNG (3.9%), Fertilizer (2.3%), Cement (1.9%) and Iron & Steel & edible oil (1.0%) each during April-January, 2018-19.



Overseas and Coastal Cargo traffic handled during April-January, 2019

 Amongst the Non-Major Ports, Gujarat Maritime Board (GMB) handled the maximum Overseas Cargo of 286.63 million tonnes with a share of 71.3% followed by Directorate of Ports, Andhra Pradesh (18.7%), MMB (4.3%), Directorate of Ports, Odisha (3.9%), Puducherry (1.7%) and TNMB & Directorate of Ports, Karnataka (0.1%) each during April-January, 2018-19 (Graph 2).



Amongst the Non-Major Ports, GMB handled the maximum Coastal Cargo of 41.24 million tonnes with a share of 54.6% followed by MMB (24.5%), Directorate of Ports, Andhra Pradesh (17.2%), A&N Islands (2.1%), Directorate of Ports, Odisha (0.7%), Directorate of Ports, Karnataka (0.4%), TNMB (0.3%) and Directorate of Ports, Kerala (0.2%) during April-January, 2018-19 (Graph 3).
