CARGO TRAFFIC HANDLED AT MAJOR PORTS DURING AND UP TO SEPTEMBER, 2022

Total Cargo traffic at India's Major Ports

Maritime transport activity is driven by developments in world economy, viz, growth in world output and trade. Thus, volume of seaborne cargo traffic handled by ports is mainly shaped by the levels and changes in both the global and domestic activity. Cargo traffic at India's 12 major ports during **April-September**, 2022-23, increased by 10.8 to 384.17 million tonnes from 346.87 million tonnes cargo handled during April-September, 2021-22.

The Overseas cargo handled at Major Ports increased by **10.9%** from 267.03 million tonnes during April-September, 2021-22 to 296.20 Million tonnes handled during April-September, 2022-23. The Coastal Cargo handled at Major port also increased by **10.2%** from 79.84 million tonnes during April-September, 2021-22 to 87.97 million tonnes handled during April-September, 2022-23.

Port-wise Cargo traffic handled during September, 2022

Cargo handled at India's major ports during September, 2022 is 61.66 million tonnes showing a increase of 15.0% as compared to the corresponding period of the previous year. The coastal cargo handled at Major Ports during September, 2022 increased by 11.5% from 12.24 million tonnes in September, 2021 to 13.64 million tonnes during September, 2022. The overseas cargo handled at Major Ports also increased by 16.0% to 48.02 million tonnes in September, 2022 as compared to 41.39 million tonnes during September, 2021.

- During September, 2022; SMP Haldia recorded the highest growth of traffic handled i.e. 29.8% followed by Visakhapatnam Port (29.5%), Paradip Port (28.5%), Mumbai Port (23.6%), Deendayal Port (18.9%), Mormugao Port (16.8%), SMP Kolkata (13.1%), JNPT (9.5%), Chennai Port (8.3%), NMPT (4.1%) and VOC Port (3.7%). Major ports that recorded negative growth in September, 2022 were Cochin Port (18.8%) and Kamarajar Port (7.0%).
- Amongst the 12 major ports, Deendayal Port handled the maximum cargo traffic of 12.27 million tonnes with a share of 19.9% in the total cargo handled at Major Ports followed by Paradip Port (15.2%), JNPT (10.5%), Visakhapatnam Port (10.1%), Mumbai Port (9.0%), Chennai Port (6.7%), SMP Haldia (6.5%), VOC Port (5.0%), Kamarajar Port (4.6%), NMPT (4.5%), Cochin Port (4.2%), SMP Kolkata (2.0%) and Mormugao Port (1.9%).
- At a broad commodity level, Other Coal achieved highest growth of 302.5 % in September, 2022 followed by Pulses (73.2%), Cement (69.2%), Fertilizer (69.1%), Sugar (55.4%), Coking Coal (33.8%), Food grain excluding pulses (27.6%), Thermal Coal (19.8%), Other

Commodities (17.3%) Iron-ore/Pellets (16.8%), POL-Crude (16.7%) and POL Products (7.0%). Project Cargo recorded highest negative growth of 25.2% in September, 2022 followed by Iron & Steel (19.0%), Other Ores (12.6%), LPG or LNG (9.6%)FRM Liquid (9.2%), Containers (3.0%), Edible Oil (1.8%) and FRM-Dry (1.6%).

• At a broad commodity level, Containers handled the maximum cargo traffic of 13.08 Million tonnes in September, 2022 with a share of 21.2% followed by POL-Crude (20.2%), Thermal Coal (13.2%), Other commodities (9.9%), POL-Products (8.3%), Coking coal (5.6%), Other coal (5.7%), Iron ore (4.4%), LPG/LNG (2.2%), Edible Oil (2.1%), Fertilizer (1.4%), Iron & Steel (1.4%), FRM-Dry(1.2%), FRM-Liquid (0.8%), Food grains excluding Pulses (0.7%) & Other Ores (0.7%) each, Cement (0.4%) & Sugar (0.4%) each, Pulses (0.2%) and Project Cargo (0.1%).

Cargo traffic handled during April-September, 2022-23

- During April-September, 2022-23, Kamarajar Port recorded highest growth of 16.4% in traffic handled at Major Ports followed by Visakhapatnam Port (15.4%), Paradip Port (13.5%), SMP Haldia (12.8%), SMP Kolkata (12.7%), Deendayal Port (12.5%), JNPT (10.5%), VOC Port (9.3%), Mumbai Port (9.2%), NMPT (7.0%), Cochin Port (6.0%) and Chennai Port (4.6%). The only Major Ports that recorded negative growth in traffic is Mormugao Port i.e.12.5% during April-September, 2022-23 over April-September, 2021-22 (Table A).
- Amongst the Major Ports, Deendayal Port handled the maximum Cargo of 70.89 million tonnes with a share of 18.5% followed by Paradip Port (16.6%), JNPT (10.5%), Visakhapatnam Port (10.0%), Mumbai Port (7.9%), Chennai Port (6.3%), SMP Haldia (5.9%), Kamarajar Port (5.8%), NMPT (5.0%), VOC Port (5.0%), Cochin Port (4.4%), Mormugao Port (2.1%) and SMP Kolkata (2.0%) during April-September, 2022-23 (Graph-I below).



 At a broad commodity level, Foodgrain excluding Pulses recorded the highest growth in traffic during April-September, 2022-23 at 136.8% followed by Other Coal (132.5%), Pulses (118.1%), Other Ores (43.3%), Cement (41.8%), Project cargo (35.2%), Thermal Coal (19.8%), Other Commodities (18.1%), POL-Crude (18.0%), FRM-Liquid (5.3%), Coking Coal (4.7%) Container (2.6%), Edible Oil (2.3%) Fertilizer (1.8%) and POL-Products (1.6%). Iron Ore pellets/fine recorded the highest negative growth of 29.1% followed by Iron & Steel (28.3%), LPG/LNG (0.8%), FRM-Dry (0.6%) and Sugar (0.5%) over April-September, 2021-22 (Table B).

• Amongst all the commodities, Container handled the maximum cargo of 84.09 million tonnes with a share of 21.9% followed by POL-Crude (20.6%), Thermal coal (14.2%), Others commodities (9.4%), POL Products (7.6%), Other coal (5.5%), Iron ore/Pellets (5.1%), Coking coal (5.0%), LPG/LNG (2.0%), Edible oil (1.5%), Food grains excluding Pulses (1.2%), Other Ores (1.1%) & Iron & Steel (1.1%) each, FRM Dry (1.0%) & Fertilizer (1.0%) each, FRM liquid (0.8%), Cement (0.4%) & Sugar (0.4%) each and Project Cargo (0.1%) during April-September, 2022-23.



Overseas and Coastal Cargo traffic handled during April-September, 2022-23

• Amongst the Major Ports, Deendayal Port handled the maximum Overseas Cargo of 64.92 million tonnes with a share of 21.9% followed by JNPT (12.8%), Paradip Port (11.9%),

Visakhapatnam Port (9.6%), Chennai Port (7.2%), SMP Haldia (6.7%), Mumbai Port (6.5%), NMPT (5.1%), Kamarajar Port (4.7%), VOC Port (4.5%), Cochin Port (4.0%), Mormugao Port (2.5%) and SMP Kolkata (2.5%) during April-September, 2022-23 (Graph II).



• Amongst the Major Ports, Paradip Port handled the maximum Coastal Cargo of 28.34 million tonnes with a share of 32.2% followed by Mumbai Port (12.7%), Visakhapatnam Port (11.5%), Kamarajar Port (9.4%), Deendayal Port (6.8%), VOC Port (6.4%), Cochin Port (6.0%), NMPT (4.7%), Chennai Port (3.4%), SMP Haldia (3.3%), JNPT (2.4%), Mormugao Port (0.8%) and SMP Kolkata (0.2%) during April-September, 2022-23 (Graph-III).
