ORDER

Subject:- Constitution of Ship Breaking Scrap Committee.

Consequent upon transfer of the subject "Ship-breaking" from Ministry of Steel to Ministry of Shipping, and in order to streamline various measures relating to modernization/up-gradation of ship breaking yards, implementation of Ship Breaking Code, 2013 and administration of ship breaking scrap fund transferred from Ministry of Steel (including various grants, budgetary support etc. obtained from different sources from time to time) etc., a Ship Breaking Scrap Committee is constituted as below:-

2. The terms of reference of the Committee shall be as below:-

- (1) It will recommend carrying out of various amendments to the Ship Breaking Code 2013 from time to time as required/felt by various associations/agencies/government bodies etc.

(2) It will ensure effective action against hazardous waste and as well as adherence to Central Pollution Control Board (CPCB) guidelines to the extent possible.

(3) It will monitor development /modernization /upgradation of infrastructure at Alang and other major ship breaking sites so as to facilitate smooth operations subject to availability of funds.

(4) It will review and institute measures to improve working conditions of labourers as well as provisions of residential housing and attention to their health needs, educational needs etc. subject to availability of funds.

(5) It will administer the Ship Breaking Scrap Fund transferred from Ministry of Steel to Ministry of Shipping and other additions to this fund from various sources.

3. The Committee will be free to co-opt experts or other invitees for the purpose of carrying out the above functions. The Committee shall meet at least once in every three months and may hold its meetings at any place where ship breaking activity takes place or is proposed to be set up. The secretarial assistance to the Committee shall be provided by the MG Section of Shipping Wing, Ministry of Shipping.
