
CARGO HANDLING STATUS FOR NON- MAJOR PORTS OF STATE MARITIME BOARD / DIRECTORATE OF PORTS DURING AUGUST 2025


Cargo handled by Non-Major Ports in India

The volume of seaborne cargo handled by ports is comprised of the global (i.e. overseas cargo) and domestic (i.e. coastal cargo) activities. There are 68 Non-Major ports, under 11 State Maritime Boards (SMB) and Directorates of Ports (DoP) which provide information on Port Data Management Portal (PDMP) of the Ministry on cargo handled by them. This publication provides data for the month of August 2025 (Advance Estimates) compared with provisional estimates of August 2024 related to Non-Major Ports. During April-August 2025-26 total cargo handled was 308.53 million tonnes (MMT) as compared to 301.71 MMT handled during April-August 2024-25. During April-August 2025-26 cargo handled at Non-Major Ports increased by 2.26% compared to April-August 2024-25. The overall trend in the cargo handled at Non-Major Ports during the past ten years is shown in Chart-I.




Cargo handled by Non-Major Ports during April-August 2025-26






Growth of Cargo handled by SMB/ DoPs in August 2025



Share of Cargo handled by SMB/ DoP in August 2025






Broadly commodities are categorized in 7 Principal commodities.

Progress in August 2025

- ➤ POL and Crude Products had maximum share of 26.60% with 19.58% growth.
- Fertilizer had maximum growth of 193.07% with a share of 2.91%.
- Coal had cargo share of 26.35%.
- Containers had cargo share of 21.87%.
- ➤ Growth was negative for Coal (2.68%) and Iron Ore (2.46%)




SMB/ DoP-wise Cargo handled during April-August 2025-26

- ➤ GMB (197.49 MMT)-Maximum APMB (51.12 MMT) MMB (27.20 MMT) Odisha (21.13 MMT) Puducherry (5.78 MMT)
- ➤ Others (Goa, Kerala, Lakshadweep, Karnataka, TNMB, A&N Islands) handled only 5.81 MMT cargo




Share of Cargo handled by SMB/ DoP during April-August 2025-26

Top performers during April-August 2025-26

- > Top 5 SMB/DoP handled 98.12% of total cargo
- ➤ Maximum cargo handled by Gujarat Maritime Board (64.01%)
- Others (Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu and A&N Islands) handled only 1.88% of total cargo




Commodity-wise Cargo handled and its growth during April-August 2025-26

Commodity-wise cargo handled

Broadly commodities are categorized in 7 Principal commodities.

Progress during April-August 2025-26 vis-à-vis April-August 2024-25

- Coal had maximum (28.83%) share with 1.99% growth
- ➤ POL and Crude Products had 26.63% share
- ➤ Container registered 20.97% share
- ➤ Growth was maximum for Fertilizer (26.20%) with share of 1.89%.
- For Growth was negative for Iron Ore (6.09%), Container (0.98%) and Foodgrains (0.93%)




SMB/ DoP -wise Overseas Cargo handled during April-August 2025-26

- ➤ Others (Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu, A&N Islands) handled only 1.92% of total cargo




SMB/ DoP-wise Coastal Cargo handled during April-August 2025-26






- ➤ Top 4 SMB/DoP handled 98.31% of total cargo
