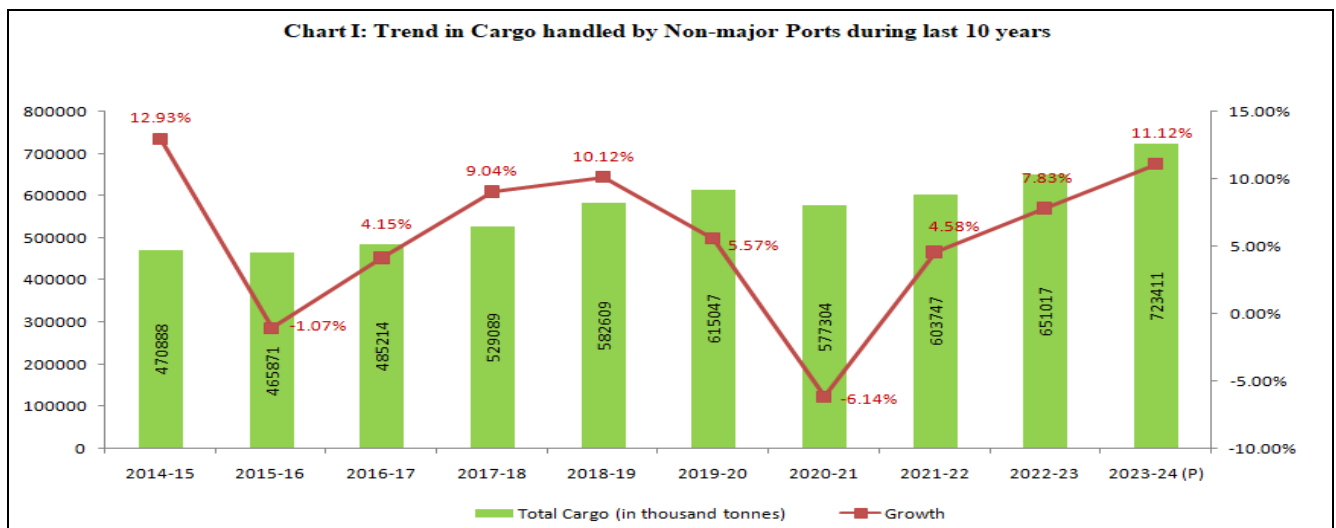


# CARGO HANDLING STATUS FOR NON- MAJOR PORTS OF STATE MARITIME BOARD / DIRECTORATE OF PORTS DURING JANUARY 2024

## Cargo handled by Non-Major Ports in India

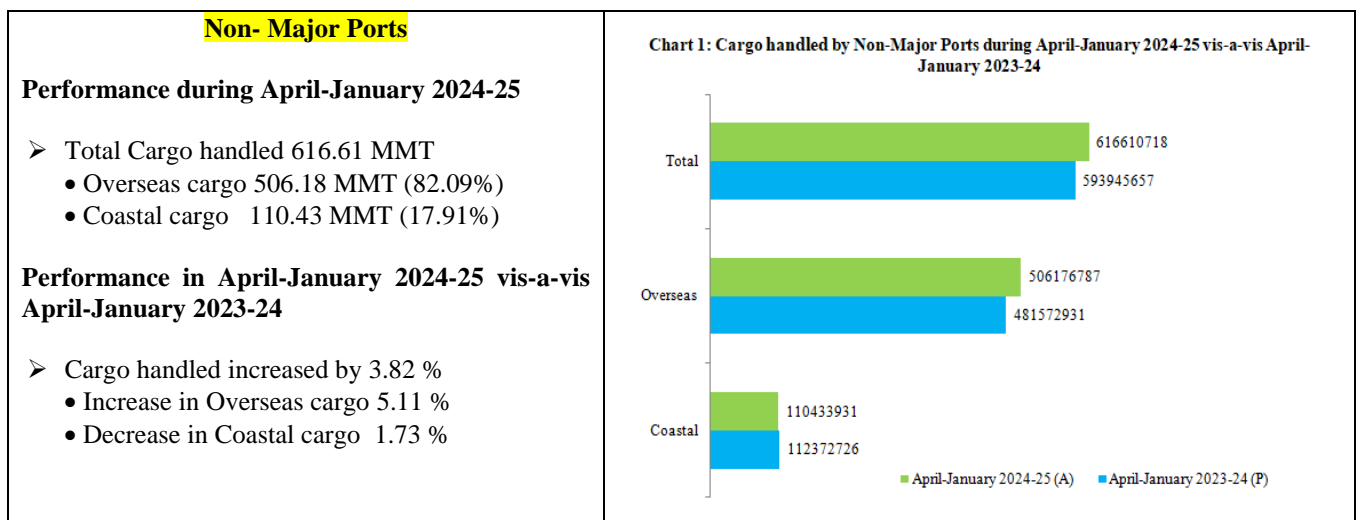
Maritime transport activity is driven by the growth in output and trade worldwide. The volume of seaborne cargo handled by ports is comprised of the global (i.e. overseas cargo) and domestic (i.e. coastal cargo) activities. There are 65 Non-Major ports under 10 State Maritime Boards (SMB) and Directorates of Ports (DoP) which provides information on Port Data Management Portal (PDMP) of the Ministry on cargo handled by them.

This publication provides data for January 2025 (Advance Estimates) compared with provisional estimates of January 2024. During April-January 2024-25 cargo handled at Non-Major Ports increased by 3.82% compared to April-January 2023-24. During April-January 2024-25 total cargo handled had increased to 616.61 million tonnes (MMT) from 593.95 MMT handled during April-January 2023-24. The overall trend in the cargo handled at Non-Major Ports during the past ten years is shown in Chart-I.

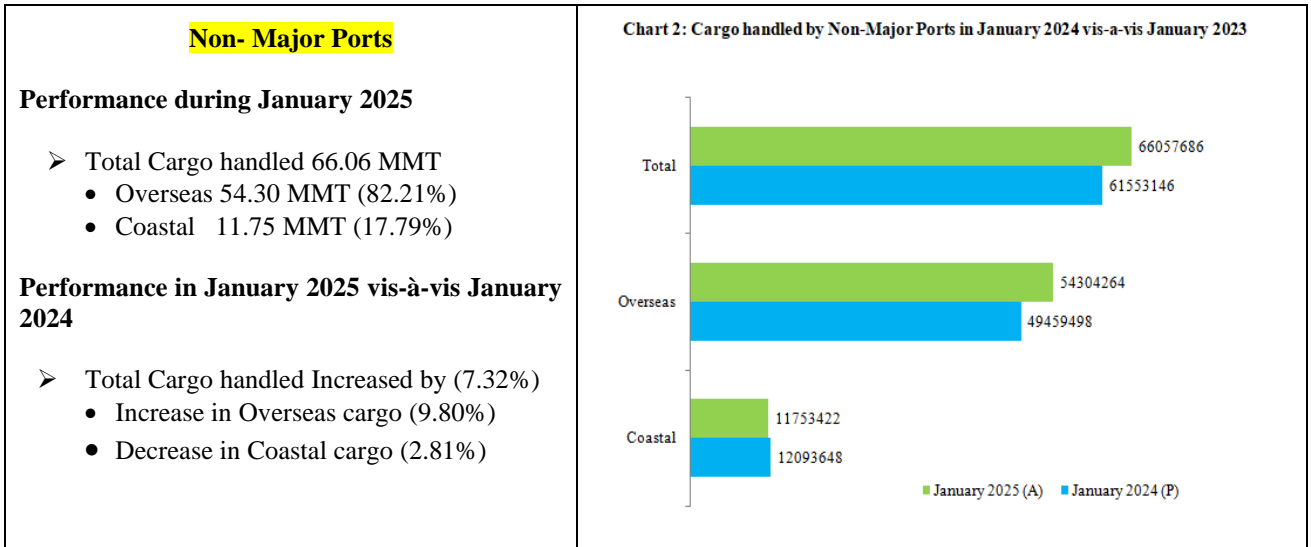

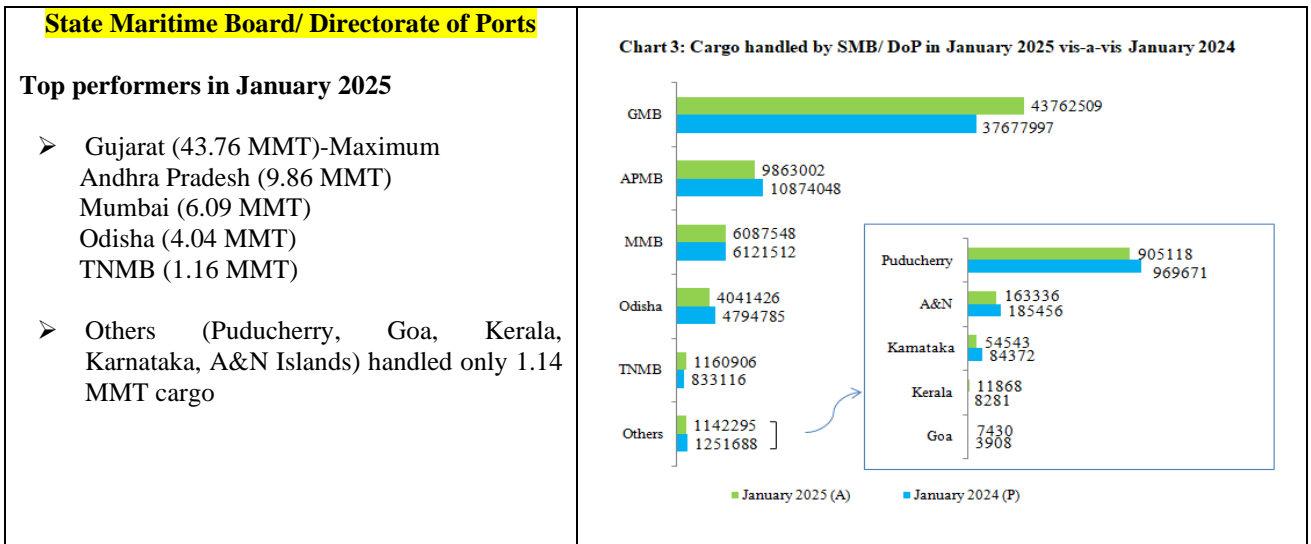
## Cargo handled by Non-Major Ports during April-January 2024-25



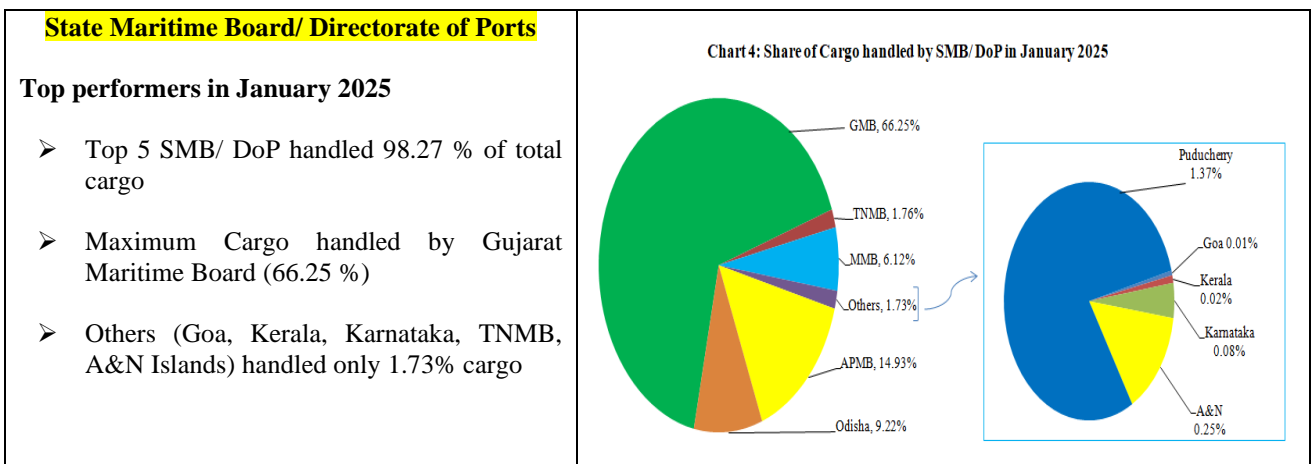
## Cargo handled by Non-Major ports in January 2025



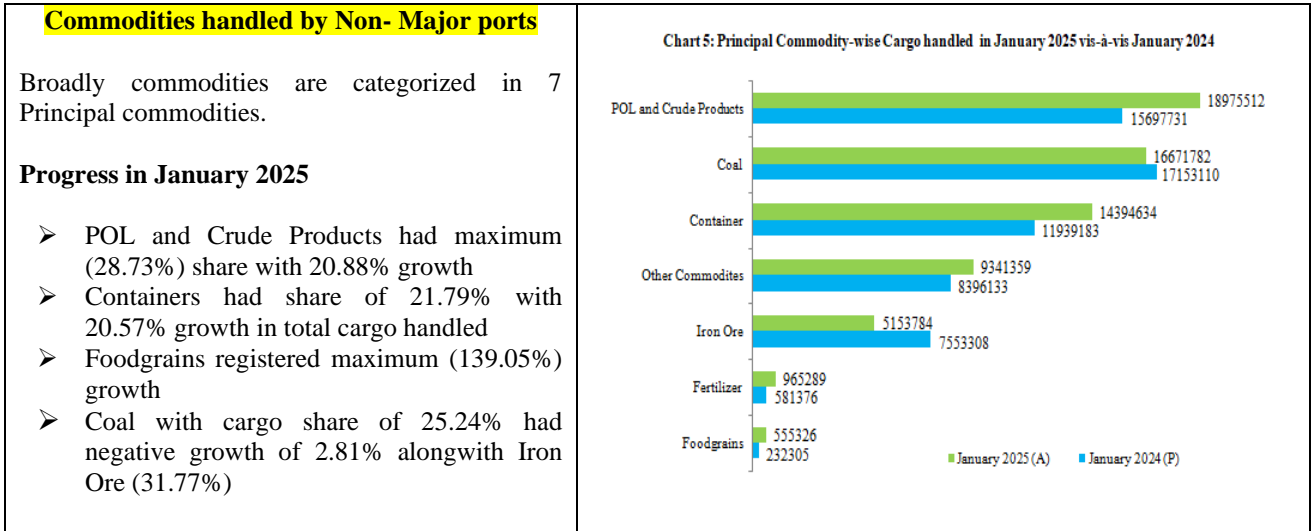
## Growth of Cargo handled by SMB/ DoPs in January 2025



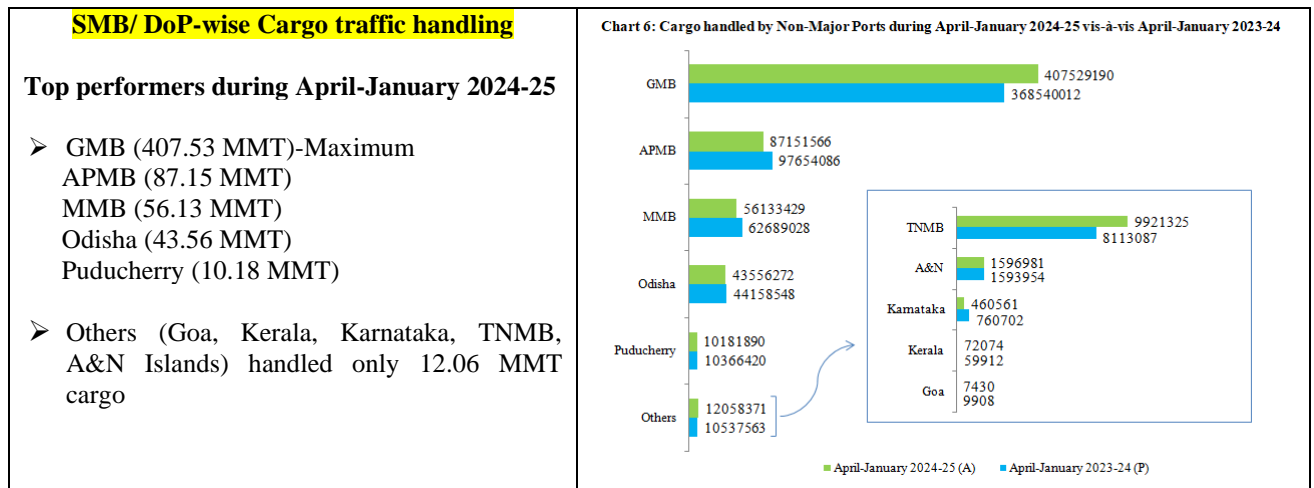
## Share of Cargo handled by SMB/ DoP in January 2025



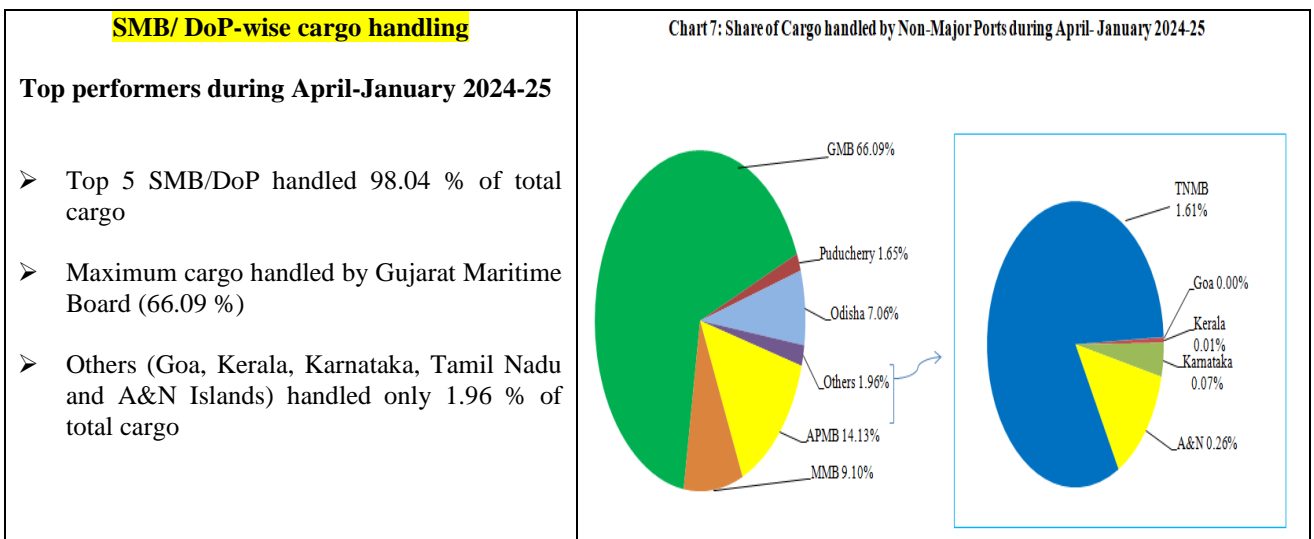
## Commodity-wise Cargo handled in January 2025

## Commodity-wise Cargo handled and its growth during April-January 2024-25

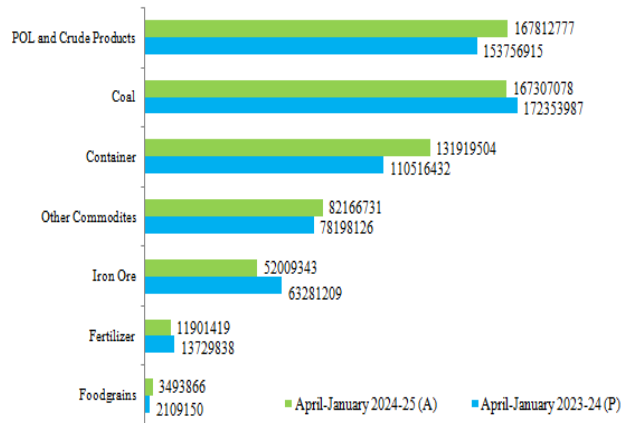
### Commodity-wise cargo handled

Broadly commodities are categorized in 7 Principal commodities.

#### Progress during April-January 2024-25 vis-à-vis April-January 2023-24

- POL and Crude Products had 27.22% share with 9.14% growth
- Container registered 21.39% growth with share of 19.37%
- Coal with cargo share of 27.13% had negative growth of 2.93% alongwith Fertilizer (13.32%) and Iron Ore (17.81%)

Chart 8: Principal Commodity-wise Cargo handled during April-January 2024-25 vis-à-vis April-January 2023-24



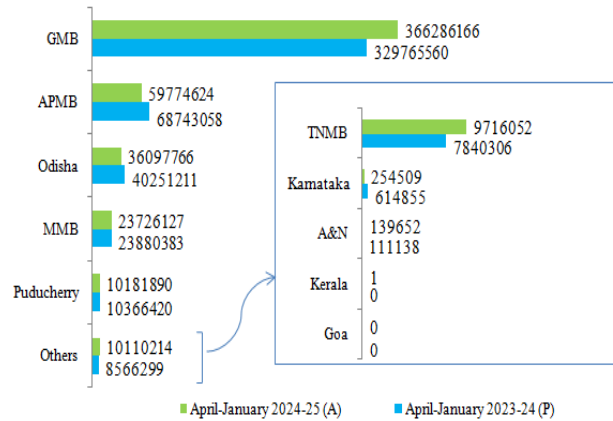
## SMB/ DoP -wise Overseas Cargo handled during April-January 2024-25

- Top 5 SMB/DoP handled 98.00 % of total cargo
- Maximum cargo handled by Gujarat (72.36%)
- Others (Goa, Kerala, Karnataka, Tamil Nadu, A&N Islands) handled only 2.00% of total cargo

Chart 9: Overseas Cargo handled by Non-Major Ports during April-January 2024-25 vis-a-vis April-January 2023-24



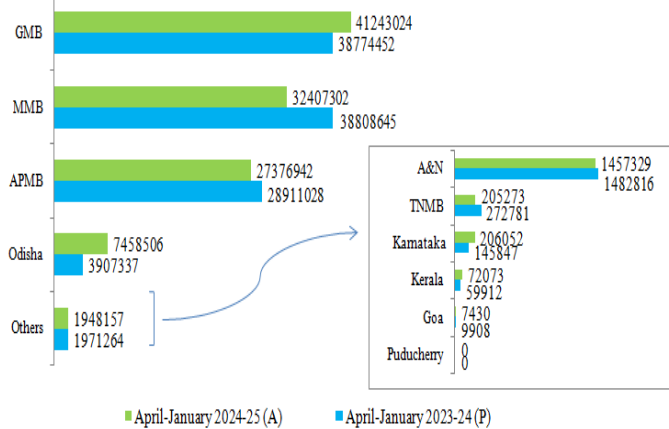

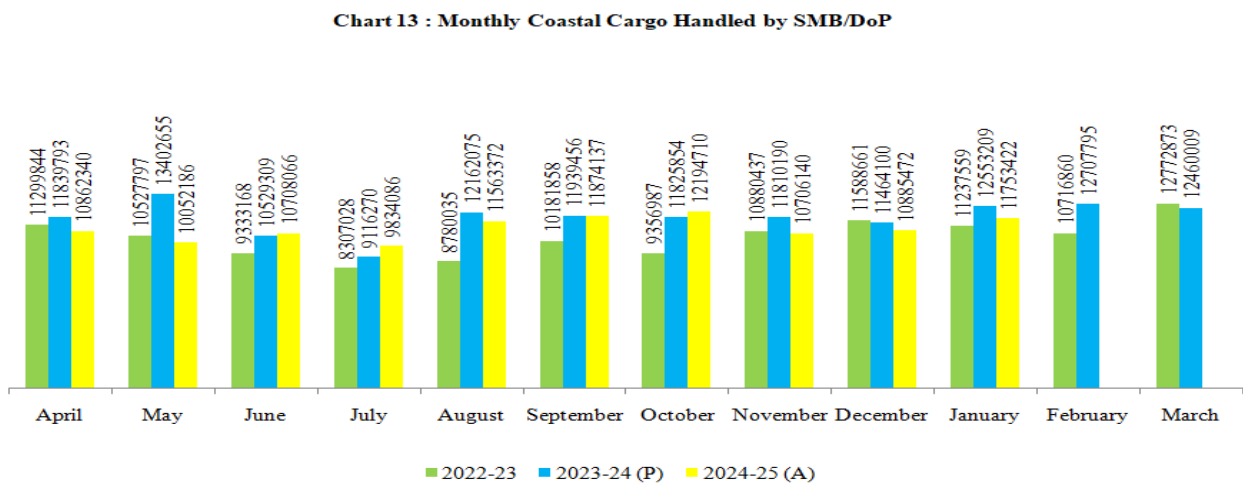
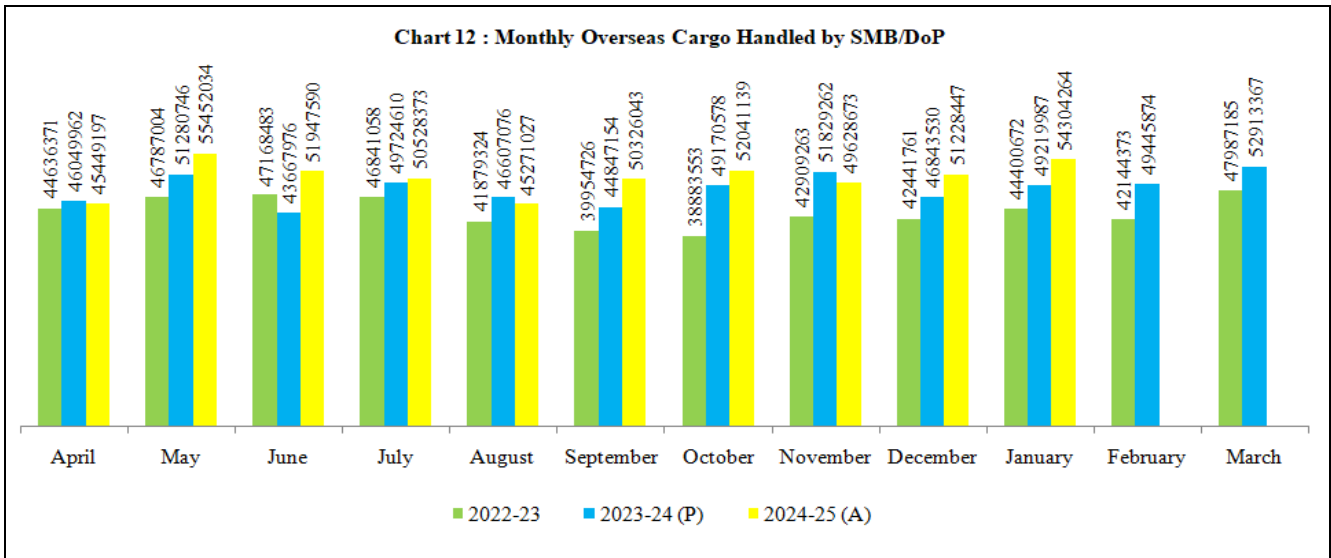
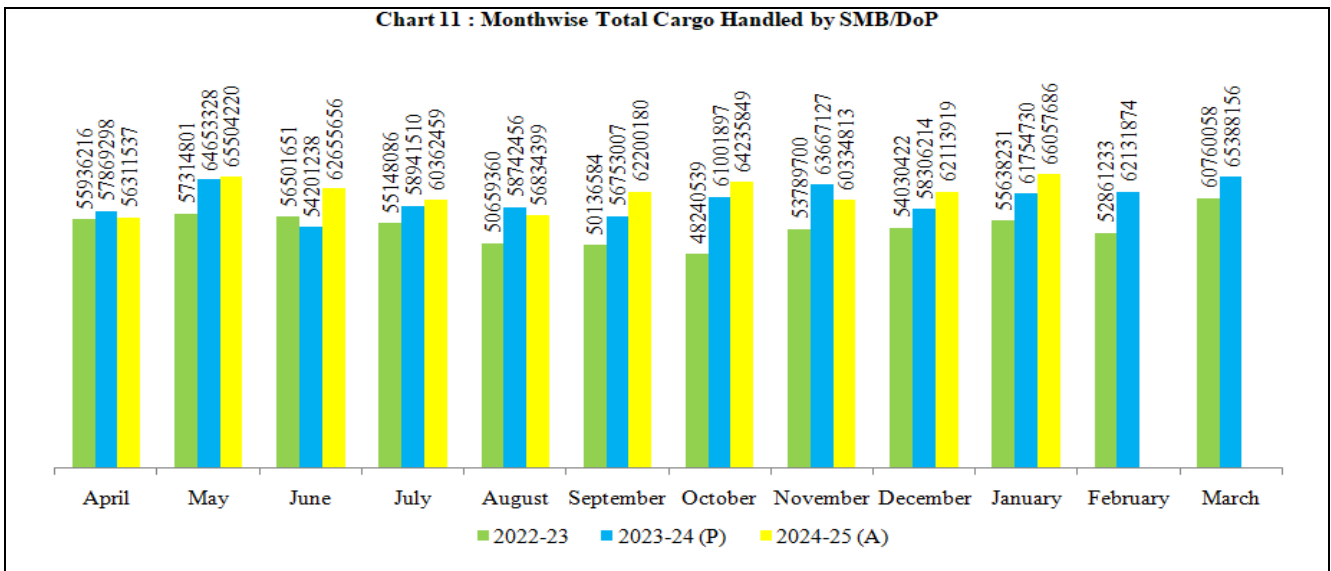
#### Top performers during April-January, 2024-25
