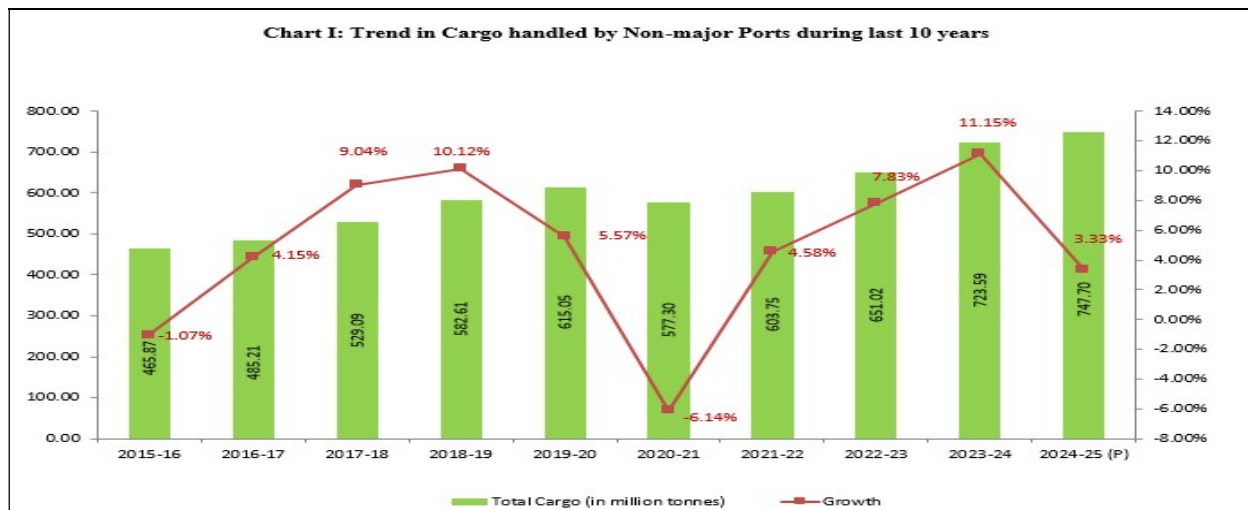


CARGO HANDLING STATUS FOR NON- MAJOR PORTS OF STATE MARITIME BOARD / DIRECTORATE OF PORTS DURING NOVEMBER 2025

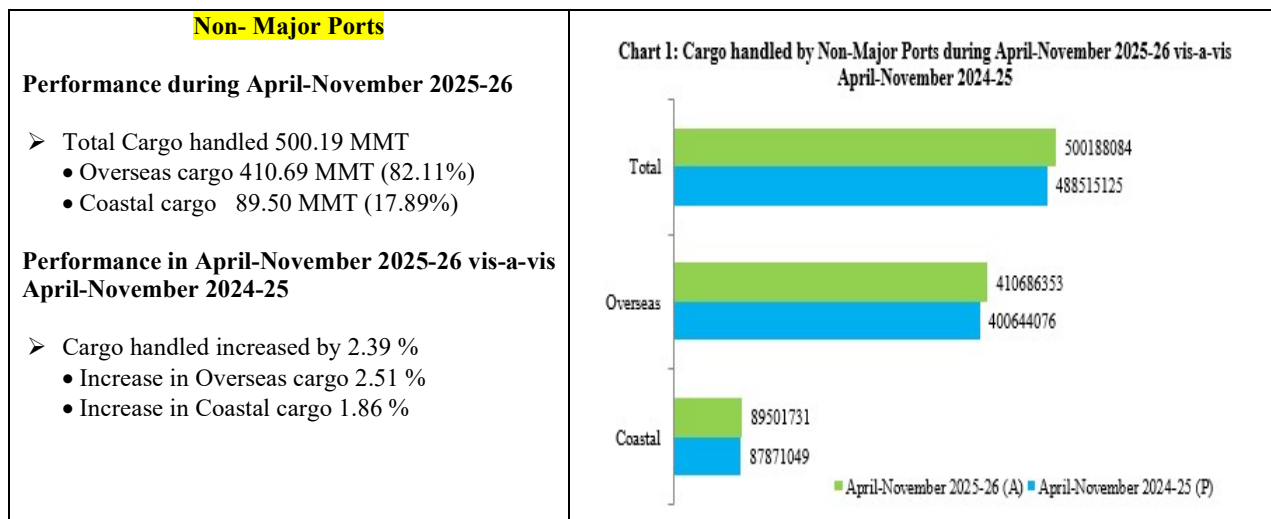
Cargo handled by Non-Major Ports in India

The volume of seaborne cargo handled by ports is comprised of the global (i.e. overseas cargo) and domestic (i.e. coastal cargo) activities. There are 68 Non-Major ports, under 11 State Maritime Boards (SMB) and Directorates of Ports (DoP) which provide information on Port Data Management Portal (PDMP) of the Ministry on cargo handled by them. This publication provides data for the month of November 2025 (Advance Estimates) compared with provisional estimates of November 2024 related to Non-Major Ports. During April-November 2025-26 total cargo handled was 500.19 million tonnes (MMT) as compared to 488.52 MMT handled during April-November 2024-25. During April-November 2025-26 cargo handled at Non-Major Ports increased by 2.39% compared to April-November 2024-25. The overall trend in the cargo handled at Non-Major Ports during the past ten years is shown in Chart-I.

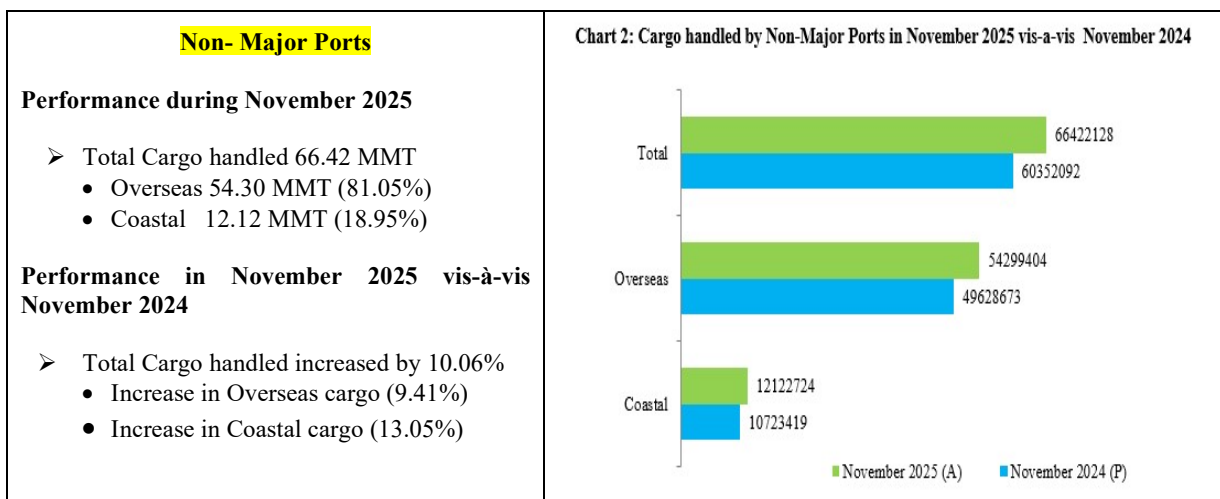

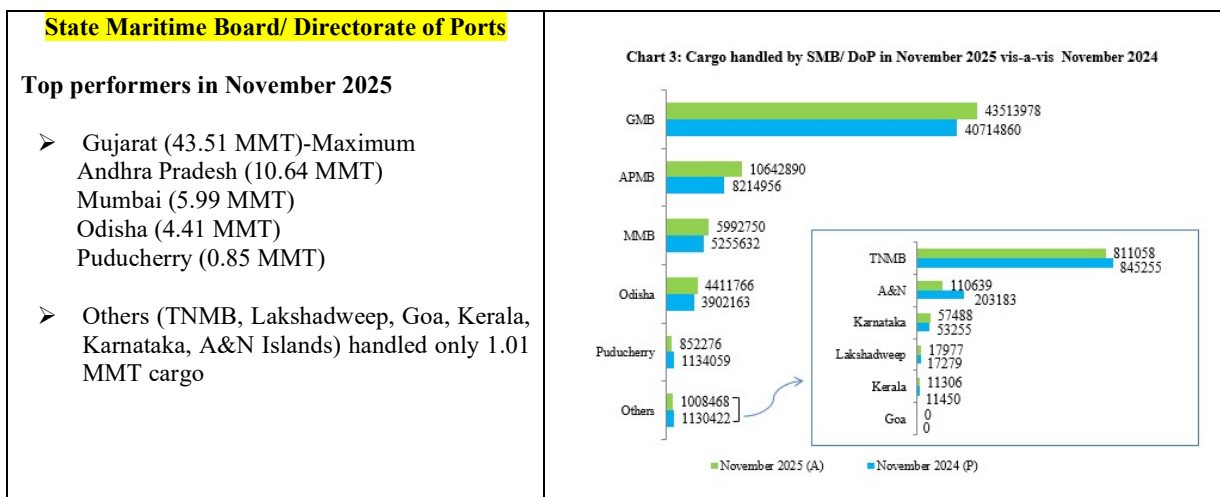
Cargo handled by Non-Major Ports during April-November 2025-26



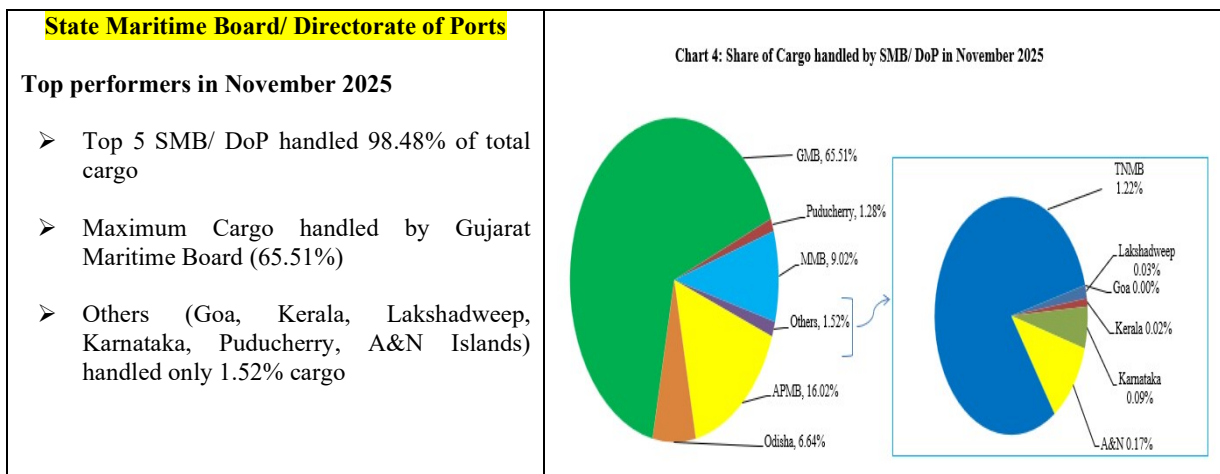
Cargo handled by Non-Major ports in November 2025

Commodity-wise Cargo handled in November 2025

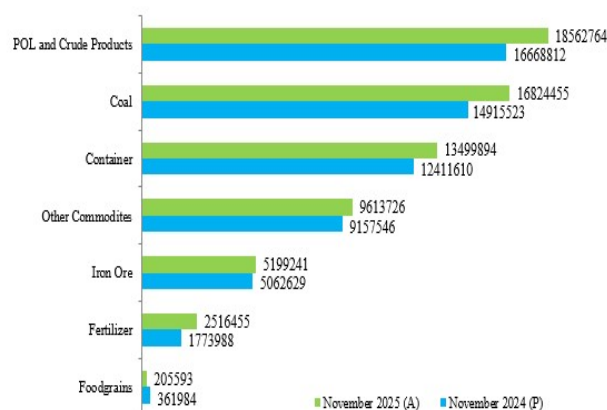
Commodities handled by Non- Major ports

Broadly commodities are categorized in 7 Principal commodities.

Progress in November 2025

- POL and Crude Products had cargo share of 27.95% with 11.36% growth.
- Coal had cargo share of 25.33% with 12.80% growth.
- Containers had cargo share of 20.32% with 8.77% growth.
- Growth was maximum for Fertilizer (41.85%) with share of 3.79%.
- Growth was negative for Foodgrains (43.20%)

Chart 5: Principal Commodity-wise Cargo handled in November 2025 vis-à-vis November 2024



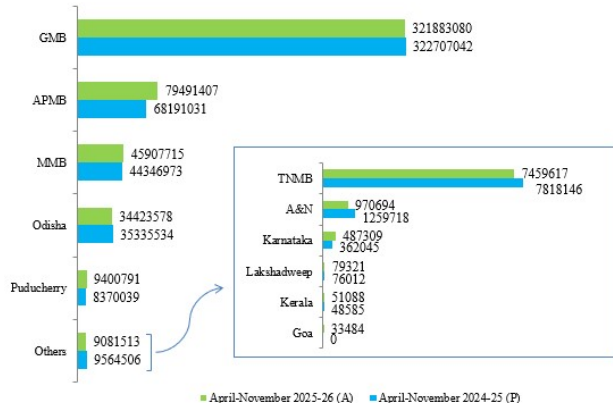

Top performers during April-November 2025-26

- GMB (321.88 MMT)-Maximum
- APMB (79.49 MMT)
- MMB (45.91 MMT)
- Odisha (34.42 MMT)
- Puducherry (9.40 MMT)
- Others (Goa, Kerala, Lakshadweep, Karnataka, TNMB, A&N Islands) handled only 9.08 MMT cargo

Chart 6: Cargo handled by Non-Major Ports during April-November 2025-26 vis-à-vis April-November 2024-25



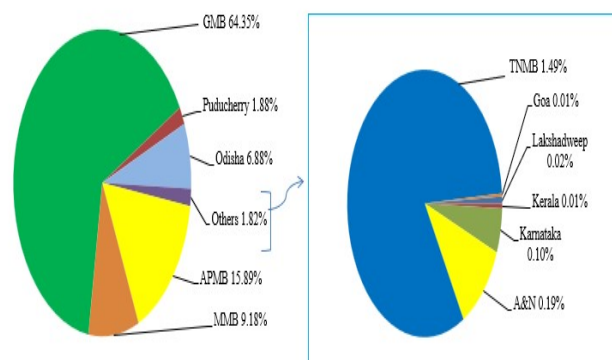
Share of Cargo handled by SMB/ DoP during April-November 2025-26

SMB/ DoP-wise cargo handling

Top performers during April-November 2025-26

- Top 5 SMB/DoP handled 98.18% of total cargo
- Maximum cargo handled by Gujarat Maritime Board (64.35%)
- Others (Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu and A&N Islands) handled only 1.82% of total cargo

Commodity-wise Cargo handled and its growth during April-November 2025-26

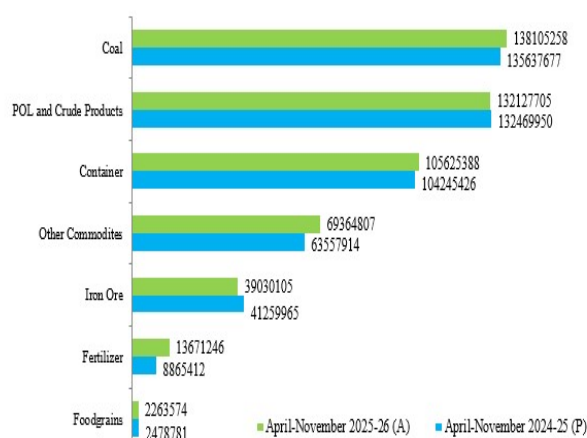
Commodity-wise cargo handled

Broadly commodities are categorized in 7 Principal commodities.

Progress during April-November 2025-26 vis-à-vis April-November 2024-25

- Coal had maximum share of 27.61% with 1.82% growth
- POL and Crude Products had 26.42% share
- Container had share of 21.14% with 1.32% growth
- Growth was maximum for Fertilizer (54.21%) with share of 2.73%.
- Growth was negative for Foodgrains (8.68%), Iron Ore (5.40%) and POL and Crude Products (0.26%)

Chart 8: Principal Commodity-wise Cargo handled during April-November 2025-26 vis-à-vis April-November 2024-25



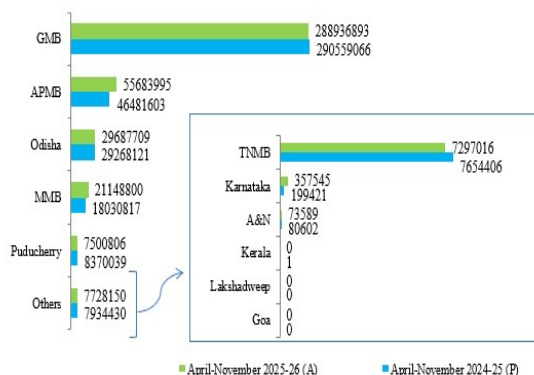
SMB/ DoP -wise Overseas Cargo handled during April-November 2025-26

Top performers during April-November 2025-26

- Top 5 SMB/DoP handled 98.12% of total cargo
- Maximum cargo handled by Gujarat (70.35%)
- Others (Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu, A&N Islands) handled only 1.88% of total cargo

Chart 9: Overseas Cargo handled by Non-Major Ports during April-November 2025-26 vis-à-vis April-November 2024-25



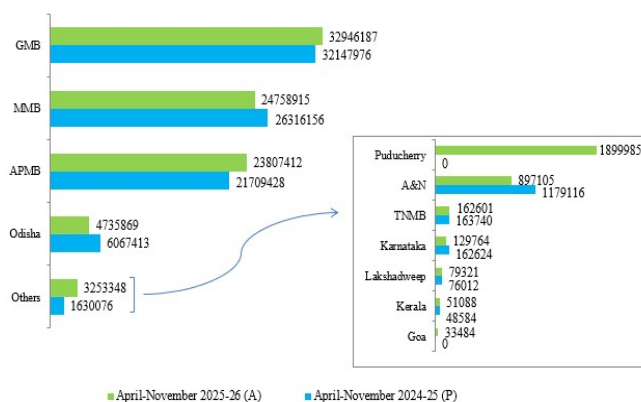
SMB/ DoP-wise Coastal Cargo handled during April-November 2025-26

Coastal Cargo handled by Non-Major Ports

Top performers during April-November, 2025-26

- Top 4 SMB/DoP handled 96.37% of total cargo
- Maximum Cargo handled by Gujarat (36.81%)
- Others (Puducherry, Goa, Kerala, Lakshadweep, Karnataka, Tamil Nadu and A&N Islands) handled 3.63% of total cargo

Chart 11 : Monthwise Total Cargo Handled by SMB/DoP

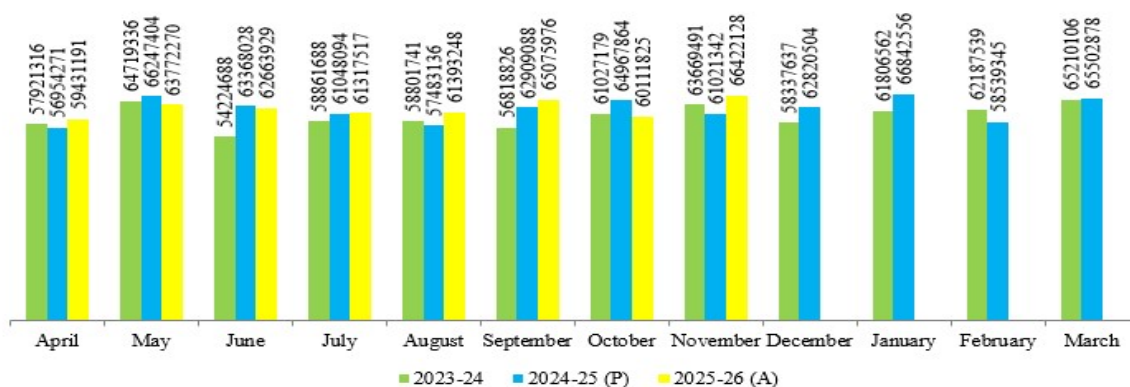


Chart 12 : Monthly Overseas Cargo Handled by SMB/DoP

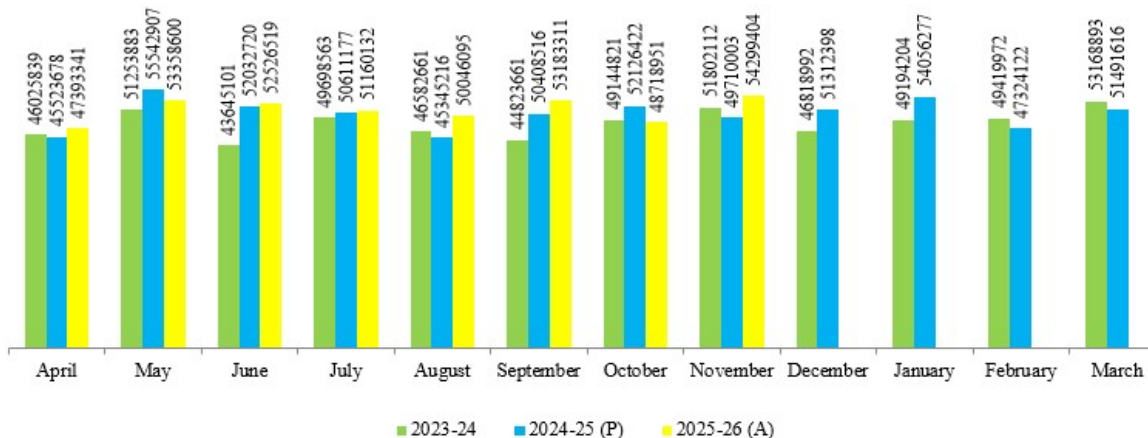
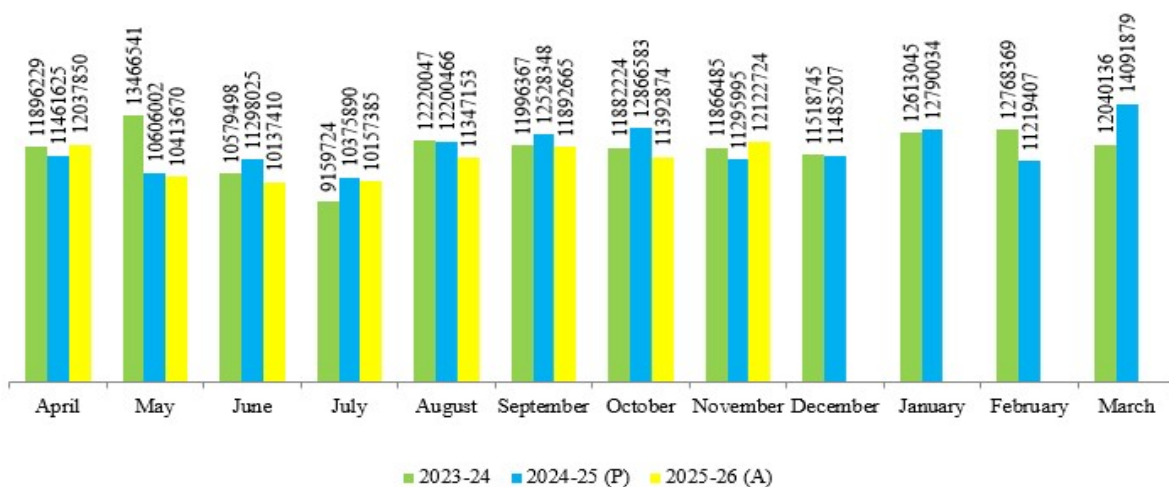


Chart 13 : Monthly Coastal Cargo Handled by SMB/DoP
