Sir,

Sub-: Filling up the post of Chief Hydraulic Engineer by absorption through composite method under KDS of Syama Prasad Mookerjee Port -- applications invited.

The post of Chief Hydraulic Engineer in the rank of Head of Department under Kolkata Dock System of Syama Prasad Mookerjee Port, Kolkata (SMPK) is to be filled up by Absorption through Composite Method from amongst the officers of Major Port Authorities, fulfilling the eligibility criteria for the concerned post, as per the **Annexure-I.**

- 2. The incumbent will initially be appointed to the HoD post in the scale of pay of Rs.1,00,000-2,60,000/- (pre-revised Rs. 43,200-66,000/-), and after completion of three years' regular service in the post, he / she will be elevated to the scale of pay of Rs.1,20,000 2,80,000/- (pre revised Rs. 51,300-73,000/-), subject to fulfilling the relevant conditions as per the Ministry's guideline vide Letter No. A-12023/15/2018-PE-I dated November 19, 2019.
- 3. The selection is by merit for which overall grading in the ACRs/APARs will not be below "Very Good".
- 4. Applications of suitable and willing officers, who satisfy the provisions of the Recruitment Rules for the post of Chief Hydraulic Engineer, may please be submitted through "Online Application Portal (OAP)" of the Ministry of Ports, Shipping & Waterways website http://onlinevacancy.shipmin.nic.in from 14.11.2025 to 15.12.2025. Therefore, all the applicants, after registering themselves in the said portal, are required to forward a printout of the filled-up application along with the following documents in an envelope, through their Administrative Port, superscripting "Application for the post of Chief Hydraulic Engineer", so as to reach the Office of the

Secretary, Syama Prasad Mookerjee Port, 15 Strand Road, Kolkata-700001 on or before 30.12.2025: -

- i) Certified copies of ACRs/APARs for the last 5 years, duly attested by an officer not below the rank of Dy. HOD on each page.
- ii) Self-attested copies of all the certificates towards proof of educational qualification, present and past work experience (in case of appointment / promotion on "officiating" and / or "ad-hoc" and / or "proforma" basis, the details of "regularization" thereon may be indicated clearly) in the respective post and pay scale, duly verified and certified through proper attestation by an officer not below the rank of Dy. HoD on each page.
- iii) No objection certificate issued by the Competent Authority from the respective Ports.
- iv) Undertaking of the applicant to the effect that the candidature will not be withdrawn, if selected.
- v) Administrative Certificate by the concerned Port (Annexure II).
- vi) Vigilance comments/clearance certificate in the pro-forma prescribed (Annexure-III), including details of penalties, if any, in last ten years (as mentioned under Sl. No. 10 of the attached Annexure-III).
- vii) Self attested passport size photographs (two numbers).
- 5. **Crucial date** for determining the eligibility will be **01.04.2026**.
- 6. In case of receipt of advance copy of application in respect of any applicant by the Port, candidature of the candidate would not be considered by the Port if his / her application is not received through proper channel within 15 days of the last date of submission of application i.e. **30.12.2025.** Incomplete application or application received after the due date will not be considered.
- 7. Further, withdrawal of candidature of any Port Official after final selection for the said post by the Service Selection Committee will be dealt in line with the relevant guidelines issued by the Ministry.
