CARGO TRAFFIC HANDLED AT MAJOR PORTS DURING AND UP TO MAY, 2020

Total Cargo traffic at India's Major Ports

Maritime transport activity is driven by developments in world economy, viz, growth in world output and trade. Thus, volume of seaborne cargo traffic handled by ports is mainly shaped by the levels and changes in both the global and domestic activity. Cargo traffic at India's 12 major ports during **April-May**, **2020-21**, **decreased by 22.2% to 92.82 million tonnes** from 119.33 million tonnes cargo handled during April-May, 2019-20.

The overseas cargo handled at Major Ports decreased by **17.9%** from 88.45 million tonnes during April-May, 2019-20 to 72.61 Million tonnes handled during April-May, 2020-21. However, the Coastal Cargo handled at Major port decreased by **34.6%** from 30.89 million tonnes during April-May, 2019-20 to 20.21 million tonnes handled during April-May, 2020-21.


Port-wise Cargo traffic handled during May, 2020

- Cargo handled at India's major ports during May, 2020 is 45.4 million tonnes showing decrease of 23.3% in the corresponding period of the previous year. The coastal cargo handled at Major Ports during May, 2020 decreased by 32.8% from 15.64 million tonnes in May, 2019 to 10.51 million tonnes during May, 2020. However, the overseas cargo handled at Major Ports decreased by 19.9% to 34.89 million tonnes in May, 2020 as compared to 43.5 million tonnes during May, 2019.
- During May, 2020; Murmugao Port recorded the highest growth of traffic handled i.e. 34.9% followed by New Mangalore Port (25.7%). The major ports which recorded negative growth in May, 2020 are Kamarajar Port (61.9%), Kolkata Dock (52.7%), Chennai Port (49.9%), Cochin Port (46.5%), Mumbai Port (35.3%), JNPT (32.3%), Haldia Dock (30.0%), Chidambararnar Port (17.8%), Paradip Port (15.7%), Visakhapatnam Port (13.2%) and Deendayal Port (12.7%).
- Amongst the 12 major ports, Deendayal Port handled the maximum cargo traffic of 8.5 million tonnes with a share of 18.8% in the total cargo handled at Major Ports followed by Paradip Port (16.6%), Vishakhapatnam Port (10.9%), JNPT (9.0%), New Mangalore Port (7.9%), Mumbai Port (7.6%), Haldia Dock Complex (6.3%), Chidambaranar Port (5.3%), Mormugao Port (5.3%), Chennai Port (4.7%), Cochin Port (3.4%), Kamarajar Port (2.5%) and Kolkata Dock System (1.7%).
- At a broad commodity level, **Sugar achieved highest growth of 200.9%** in May, 2020 followed by Iron and Steel (70.5%), Other Coal (31.5%), Iron-ore (22.0%), LPG/LNG

- (20.9%) and FRM-Dry (3.7%). Thermal Coal recorded highest negative growth of 64.0% in May, 2020 followed Food Grain excluding Pulses (60.5%), Cement (46.3%), Edible oil (45.0%), Other Commodities (38.1%), Containers (34.1%), Project Cargo (34.0%), Coking Coal (33.7%), FRM-Liquid (20.7%), POL-Crude (17.1%), POL-Products (14.7%), Fertilizers (13.9%) and Other ores (13.8%).
- At a broad commodity level, POL-Crude handled the maximum cargo traffic of **10.13 Million tonnes** in May, 2020 with a share of 22.3% followed by Container (18.7%), Iron ore (12.8%), POL Products (10.3%), Other commodities (7.0%), Thermal Coal (6.1%), Other coal (5.4%), Coking coal (5.0%), LPG/LNG (2.5%), Iron & Steel (2.3%), Fertilizer (1.7%), Edible Oil (1.3%), Sugar (1.1%), FRM-Liquid, FRM Dry and Other Ores (0.9%) each, Cement (0.5%), Food grains excluding Pulses (0.1%) and Project Cargo (0.1%).

Cargo traffic handled during April-May, 2020-21

- During April-May, 2020-21, Mormugao Port recorded highest growth in traffic handled at 21.5% followed by New Mangalore Port (10.4%). Major ports that recorded negative growth in traffic during April-May, 2020-21 were: Kolkata Dock (47.3%), Kamarajar Port (46.1%), Chennai Port (44.2%), Cochin Port (40.1%), JNPT (33.1%), Mumbai Port (27.1%), Haldia Dock (25.3%), V.O.C Port (21.7%), Deendayal Port (18.4%), Paradip Port (12.9%) and Vishakhapatnam Port (12.6%) over April-May, 2019-20 (**Table A**).
- Amongst the Major Ports, Deendayal Port handled the maximum Cargo of 17.19 million tonnes with a share of 18.5% followed by Paradip Port (17.3%), Vishakhapatnam Port (10.7%), JNPT (8.7%), Mumbai Port (8.1%), New Mangalore Port (7.3%), Haldia Dock Complex (6.0%), Chidambaranar Port (5.1%), Chennai Port (4.9%), Mormugao Port (4.3%), Cochin Port (3.7%), Kamarajar Port (3.5%) and Kolkata Dock System (1.8%) during April-May, 2020-21 (**Graph- I below**).

• At a broad commodity level, **Sugar recorded** the **highest growth in traffic at 142.2%** followed by Pulses (71.5%), Iron & Steel (42.9%), FRM-Dry (34.0%), other ores (15.0%),

LPG/LNG (13.0%) and Iron ore (7.0%). Food Grains excluding pulses recorded the highest negative growth of 52.5% followed by Cement (51.4%), Project Cargo (50.4%), Thermal Coal (42.6%), Edible Oil (40.0%), Container (33.9%), FRM-Liquid (31.3%), other coal (17.7%), Coking Coal (17.4%), POL-Crude (17.3%), Fertilizer (14.7%) and POL-Product (12.7%) over April-May, 2019-20 (**Table B**).

• Amongst all the commodities, POL-Crude handled the maximum cargo of 20.53 million tonnes with a share of 22.1% followed by Container (18.1%), Thermal coal (11.1%), POL Products (10.1%), Iron ore (10.0%), Others commodities (7.1%), Coking coal (5.8%), Other coal (4.3%), LPG/LNG (2.4%), Iron & Steel (1.9%), Edible oil (1.3%), Fertilizer (1.2%), Sugar (1.1%), Other ores (1.0%), FRM Dry (0.9%), FRM liquid (0.8%), Cement (0.4%) and Project Cargo and Foodgrains excluding Pulses (0.1%) each during April-May, 2020-21.



Overseas and Coastal Cargo traffic handled during April-May, 2020-21

• Amongst the Major Ports, Deendayal Port handled the maximum Overseas Cargo of 14.6 million tonnes with a share of 20.1% followed by Paradip Port (16.5%), JNPT (10.1%), Vishakhapatnam Port (10.3%), New Mangalore Port (7.7%), Haldia Dock (6.3%), Mumbai Port (6.2%), Chennai Port (5.6%), Mormugao Port (5.3%), Chidambaranar Port (4.6%), Cochin Port (2.9%), Kolkata Dock (2.3%) and Kamarajar Port (2.1%) during April-May, 2020-21 (Graph II).



• Amongst the Major Ports, Paradip Port handled the maximum Coastal Cargo of 4.09 million tonnes with a share of 20.2% followed by Mumbai Port (15.1%), Deendayal Port (12.9%), Vishakhapatnam Port (12.1%), Kamarajar Port (8.5%), Chidambaranar Port (6.9%), Cochin Port (6.4%), New Mangalore Port (6.1%), Haldia Dock (5.2%), JNPT (3.3%), Chennai Port (2.5%), Mormugao Port (0.6%) and Kolkata Dock (0.1%) during April-May, 2020-21 (**Graph III**).
