Sub: Filling up the post of Member (Technical) in level-14 of the 7th CPC Pay Matrix (Pre-revised pay scale of Rs. 37,400-67000/- with Grade Pay of Rs. 10000/-) in Inland Waterways Authority of India (IWAI), NOIDA, UP on Deputation basis-reg.

Applications from eligible candidates are invited for filling up one post of Member (Technical) in Inland Waterways Authority of India (IWAI), NOIDA, Uttar Pradesh, an autonomous body under Ministry of Port, Shipping and Waterways, on deputation basis. The Post is in the Level-14 of the 7th CPC Pay Matrix (Pre-revised pay scale of Rs. 37,400-67000/- with Grade Pay of Rs. 10000/-). The term of deputation of Member (Technical) will be for a period of three (03) years, extendable upto five (05) years. Member (Technical) is a full-time Member of the Board of IWAI.

2. The Member (Technical) will be responsible for:

- (i) Investigation, planning and formulation of shipping and navigation infrastructure projects on inland waterways and their execution and maintenance
- (ii) Development of fairway of National Waterways (NWs) keeping in view their river hydrology, morphology and sedimentation behaviour
- (iii) Carrying out river conservancy works and river training works for safety and convenience of shipping and navigation on waterways
- (iv) Operation, management, repair and maintenance of vessels related development and maintenance of Inland/Coastal Waterways
- (v) Implementation of Traffic regulations on NWs and supervision of navigation, hydrographic surveys etc.
- (vi) Organizing and conducting studies/surveys on NWs and other potential inland waterways
- (vii) Project implementation with the multi-lateral agencies
- (viii) Handling of international waterways development project with MEA
- (ix) Rendering technical advice and expertise to the IWAI

(x) Any other responsibility assigned by Chairman, IWAI

3. As a Member of the Authority, Member (Technical) will be entitled for accommodation as per IWAI Rules, 1986.

4. The applicants fulfilling the following eligibility criteria may apply for the post:-

(a) (i) **Age-** Not exceeding 55 years on the closing date of receipt of applications

(ii) **Term:** 3 years, extendable up to 5 years

(i) Officers of Organized Engineering Services (Group A) having 7 years' experience in Civil Structure and holding analogous post in the level 14 of the Pay Matrix of 7th CPC (Pre Revised Pay Scale of PB-IV of Rs. 37,400-67,000/- + Grade Pay 10,000/-)

Officers of Organized Engineering Services (Group A) or officers of IWAI/Ports/PSUs/Autonomous Bodies having seven (07) years experience of Civil Structure and five (05) years' Service in the Level 13 of the Pay Matrix of 7th CPC (Pre-Revised Pay Scale of PB- 4 of Rs. 37,400-67,000/-+GP Rs.8700/-).

Five (05) years' experience as Chief Engineer of any Major Ports.

(ii) Preference will be given to the officers having adequate experience in the Inland Water Transport Sector or related fields
