
CARGO HANDLING STATUS FOR MAJOR PORTS DURING MARCH 2025


Cargo Traffic of Major Ports in India

Maritime transport activity is driven by the growth in output and trade worldwide. The volume of seaborne cargo handled by ports is comprised of the global (i.e. overseas cargo) and domestic (i.e. coastal cargo) activities. There are 12 Major Ports under Ministry of Ports, Shipping and Waterways, which provide monthly information on Port Data Management Portal (PDMP) of the Ministry on cargo handled by them.


This publication provides data for March 2025 (Advance Estimates) compared with provisional estimates of March 2024. During April- March 2024-25 cargo handled at Major Ports increased by 4.22% compared to April-March 2023-24. During April- March 2024-25 total cargo handled had increased to 853.57 million tonnes (MMT) from 819.00 MMT handled during April- March 2023-24. The overall trend in the cargo handled at Major Ports during the past ten years is shown in Chart-I.




Cargo handled by Major Ports during April-March 2024-25




Cargo handled by Major ports in March 2025




Growth of Cargo handled by Major Ports in March 2025



Share of Cargo handled by Major Ports in March 2025




Commodity-wise Cargo handled in March 2025

Progress in March 2025

- ➤ POL and Crude Products had maximum (31.16%) share with growth of 12.70%
- Foodgrains had maximum growth of 174.91%
- ➤ Containers had 20.94% share and growth of 9.49%
- Coal had 19.48% share with negative growth of 2.58%
- ➤ Iron Ore had negative growth of 3.43%




Commodity-wise Cargo handled and its Growth during April- March 2024-25

Broadly commodities are categorized in 7 Principal commodities.

Progress during April- March 2024-25 visà-vis April- March 2023-24

- ➤ POL and Crude Products had maximum (29.63%) share in the total cargo handled
- Container had share of 22.66%
- Foodgrains registered maximum (270.89%) growth
- ➤ Growth was negative for Iron ore (18.68%) and Coal (2.97%)




Major Port-wise Overseas Cargo handling during April- March 2024-25

- Minimum cargo (2.07%) handled by Mormugao




Major Port-wise Coastal Cargo handled during April- March 2024-25






