CARGO HANDLED AT STATE MARITIME/ STATE DIRECTORATE (Non-Major Ports) DURING AND UP TO JANUARY, 2022

Total Cargo traffic at India's State Maritime/ State Directorate

Maritime transport activity is driven by developments in world economy, viz, growth in world output and trade. Thus, volume of seaborne cargo traffic handled by ports is mainly shaped by the levels and changes in both the global and domestic activity. Cargo traffic at Non-Major Ports during **April-January**, 2021-22, increased by 3.7% to 490.57 million tonnes from 472.94 million tonnes handled during April-January, 2020-21.

The overseas cargo traffic handled at Non-Major Ports during April-January, 2021-22 increased by 1.6% to 419.88 million tonnes from 413.27 million tonnes during April-January, 2020-21. The coastal cargo traffic handled at Non-Major Ports during April-January, 2021-22 increased by 18.5% to 70.69 million tonnes from 59.67 million tonnes handled during April-January, 2020-21.


Port-wise Cargo traffic handled during January, 2022

- Cargo handled at Non-Major Ports during January, 2022 is 49.31 million tonnes showing a decrease in growth of 9.3% as compared to the corresponding period of the previous year. The coastal cargo traffic handled at Non-Major Ports during January, 2022 increased by 21.3% to 8.78 million tonnes from 7.24 million tonnes during January, 2021. However, the overseas cargo handled at Non-Major Ports during January, 2022 decreased by 14.0% to 40.53 million tonnes from 47.12 million tonnes during January, 2021.
- During January, 2022, the Non-Major Ports of Kerala Maritime Board (KMB) recorded highest growth in traffic of 178.6% as compared to the corresponding period of the previous year, followed by the Non-Major Ports of Directorate of Ports, Pudducherry (48.7%), Ports Management Board, A&N (29.3%), Directorate of Ports, Karnataka (29.1%) and Maharashtra Maritime Board (MMB) (24.0%). The State Maritime/ State Directorate which recorded negative growth in January, 2022 are Captain of Ports, Goa (100.0%) followed by Tamil Nadu Maritime Board (TNMB) (27.1%), Directorate of Ports, Odisha (26.5%), Andhra Pradesh Maritime Board (APMB) (23.6%) and Gujarat Maritime Board (GMB) (8.3%).
- During January, 2022, amongst the State Maritime/ State Directorate, Gujarat Maritime Board handled the maximum cargo traffic at 33.07 million tonnes with a share of (67.1%) in the total cargo handled at State Maritime/State Directorate followed by Andhra Pradesh Maritime Board (13.4%), Maharashtra Maritime Board (10.2%), Directorate of Ports, Odisha (5.8%), Tamil Nadu Maritime Board (1.6%), Directorate of Ports, Puducherry (1.4%), Ports Management Board, A&N Islands and Directorate of Ports, Karnataka (0.3%) each and Kerala Maritime Board (0.1%).

- At a broad commodity level, **Sugar achieved highest growth of 349.4%** in January, 2022 as compared to the corresponding period of the previous year followed by Building Material (142.9%), Food-grains excluding Pulses (81.5%), Fertilizer (47.0%), Project Cargo (23.4%), Edible Oil (18.2%), Other Commodities (17.6%) and Iron ore Pellets/ Fine (6.2%). **Pulses** recorded highest negative growth of 100.0% in January, 2022 followed by Thermal Coal (69.7%), Other Ores (23.1%), FRM Liquid (20.5%), Other Coal (19.6%), Coking Coal (15.8%), LPG or LNG (14.3%), Containers (13.6%), Cement (9.5%), Iron and Steel (4.2%), POL Products (2.4%) and POL Crude (1.9%).
- At a broad commodity level, Container handled the maximum cargo traffic of **9.30 Million tonnes** with share of **18.9%** in January 2022 followed by POL Crude (14.7%), Other Commodities (13.8%), POL Products (11.1%), Other Coal (10.6%), Iron ore Pellets/ Fine (8.5%), Coking Coal (6.8%), LPG or LNG (3.3%), Thermal Coal (3.0%), Fertilizer (2.5%), Cement (2.1%), Food-grains excluding Pulses (1.1%), Sugar (1.0%), Iron & Steel (0.9%), Edible Oil (0.6%), Building Material (0.4%), Other Ores and FRM Liquid (0.2%) each and Project Cargo and FRM Dry (0.1%) each.

Cargo traffic handled during April-January, 2021-22

• During the April-January, 2021-22, **Kerala Maritime Board** recorded highest growth in traffic at 218.7% although there is a negligible share in total cargo handled by non-major ports of State Maritime/ State Directorate of 490.57 million tonnes followed by Maharashtra Maritime Board (28.5%), Gujarat Maritime Board (4.8%), Ports Management Board, A&N (3.7%) and Captain of Ports, Goa (0.7%). State Maritime/ State Directorate that recorded negative growth in traffic during April-January, 2021-22 was Directorate of Ports, Puducherry (28.8%) followed by Tamil Nadu Maritime Board (18.7%), Directorate of Ports, Odisha (2.7%), Directorate of Ports, Karnataka (2.4%) and Andhra Pradesh Maritime Board (2.2%) over April-January, 2020-21 (**Table-1**).



• Amongst the State Maritime/ State Directorate, Gujarat Maritime Board handled the maximum Cargo of 333.51 million tonnes with a share of 68.0% followed by Andhra Pradesh Maritime Board (14.9%), Maharashtra Maritime Board (7.5%), Directorate of Ports, Odisha (7.0%), Tamil Nadu Maritime Board (1.3%), Directorate of Ports, Puducherry (0.9%), A&N Islands (0.2%) and Directorate of Ports Karnataka (0.1%) during April-January, 2021-22 (**Graph 1 above**).

- During the April-January, 2021-22, FRM Dry record highest growth of 96.1% followed by Foodgrains excluding Pulses (68.5%), Project Cargo (64.9%), Building Material (41.9%), Sugar (27.1%), Iron and Steel (12.8%), Containers (11.3%), Other Coal (10.8%), Coking Coal (10.7%), Cement (9.4%), Other Commodities (9.0%), POL Products (7.7%), POL Crude (6.9%) and Iron Ore (0.4%). Pulses recorded highest negative growth of 43.4% in traffic during April-January, 2021-22 followed by Thermal Coal (37.7%), Other Ores (25.9%), Fertilizer (17.9%), LPG or LNG (11.1%), FRM Liquid (9.7%) and Edible Oil (7.5%) over April-January, 2020-21 (**Table 2**).
- Amongst all commodities, Container is the highest commodity handled at ports of 93.44 million tonnes with a share of 19.0% followed by POL Crude (15.3%), Other Coal (13.3%), POL Products (11.9%), Other commodities (11.4%), Iron Ore/Pellets (6.8%), Coking Coal (6.1%), Thermal Coal (4.4%), LPG & LNG (3.8%), Fertilizer (2.2%), Cement (1.8%), Iron & Steel (1.3%), Foodgrains excluding Pulses (0.8%), Edible Oil (0.6%), Sugar (0.5%), Other Ores (0.3%), FRM Liquid and Building Material (0.2%) each during April-January, 2021-22.



Overseas and Coastal Cargo traffic handled during April-January, 2021-22

• Amongst the Non-Major Ports, Gujarat Maritime Board handled the maximum Overseas Cargo of 296.21 million tonnes with a share of 70.5% followed by Andhra Pradesh Maritime Board (15.0%), Directorate of Ports, Odisha (7.7%), Maharashtra Maritime Board (4.1%), Tamil Nadu Maritime Board (1.4%), Puducherry (1.1%) and Directorate of Ports, Karnataka (0.1%) during April-January, 2021-22 (**Graph 2**).



Amongst the Non-Major Ports, Gujarat Maritime Board handled the maximum Coastal Cargo of 37.30 million tonnes with a share of 52.8% followed by Maharashtra Maritime Board (27.7%), Andhra Pradesh Maritime Board (13.9%), Directorate of Ports, Odisha (2.8%), A&N Islands (1.6%), Tamil Nadu Maritime Board (0.6%), Kerala Maritime Board (0.3%) and Directorate of Ports, Karnataka (0.2%) each during April-January, 2021-22 (**Graph 3**).
